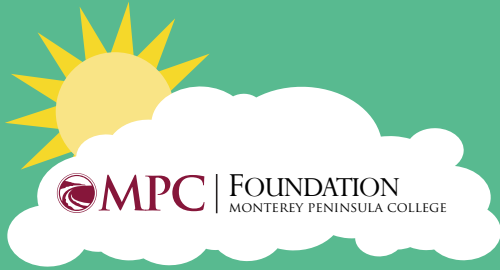

Howard & Karin Evans College Incentive Program

By combining financial incentives with wrap-around support services, our College Incentive program empowers high school students who are unlikely to attend or complete college to enroll full-time at MPC. In its first year, the Evans program achieved an unbelievable 85% success rate, with 57 students from our initial group of 67 completing their first semester of college and all program requirements.

Evans Program Demographics:

- 78%** Are first-generation college students
- 41%** Speak English as their second language
- 78%** Are an ethnicity other than White
- 43%** Live in households earning less than \$25,000
